

Warwickshire Local Government Reorganisation ENGAGEMENT QUESTIONNAIRE

Four of Warwickshire's district and borough councils (North Warwickshire, Nuneaton & Bedworth, Stratford-on-Avon, and Warwick) have appointed ORS, as an independent social research company, to manage the engagement and questionnaire responses. ORS will faithfully report the outcomes, in which the views of individual members of the public will be anonymous; but where feedback is from organisations or elected representatives or someone acting in their official capacity, it may be attributed.

Warwickshire currently operates in what is often called a 'two-tier' structure – in which major services are divided between Warwickshire County Council and the five district and borough councils.

The County Council is responsible for services like education, social care, and transport, while the district and borough councils are responsible for services like waste and recycling collection, council tax and housing.

The UK government wants to make local government simpler and more efficient by reducing the number of councils and creating unitary authorities that would deliver these services. It has asked all six Warwickshire councils to work together and come up with a plan for how this could work.

While the two-tier system has served communities well for years, the government believes change is needed now, and four of Warwickshire's district and borough councils (North Warwickshire, Nuneaton & Bedworth, Stratford-on-Avon, and Warwick - subsequently referred to as 'the councils') have collaborated on a plan that would abolish the existing councils and create a smaller number of new unitary councils.

The councils recognise that the proposals may offer an opportunity to streamline services, bring efficiencies (such as by reducing the number of senior leadership positions), and make things simpler.

The councils recognise that there are many different factors to consider when thinking about the future arrangements for local government in the area. They believe any future arrangements should provide:

- » **Accountability:** democratic decision making that can be locally influenced and ensuring residents know how to raise issues to their local councillor and how to have a say on future service delivery
- » **Quality:** frontline services that are sustainable, cost-effective and equipped to deliver good local services in the long-term
- » **Local Identity:** boundaries that reflects how residents live their lives and how businesses operate
- » **Access:** keeping services as local as possible for as many residents as possible
- » **Value For Money:** cutting out duplication, increasing economies of scale and improving efficiencies

The councils recognise that they will need to find the right balance between these different criteria when deciding the best arrangements for local government in the area.

The councils considered two potential future options for local government in Warwickshire:

- 1) A single county-wide unitary council covering the whole of Warwickshire
- 2) Two unitary councils for North and South Warwickshire

The councils of North Warwickshire, Nuneaton & Bedworth, Stratford-on-Avon and Warwick have all determined that their preferred option is for two unitary councils. Rugby Borough Council has not determined a preferred option at this stage.

It is worth noting that further research is being undertaken. This includes determining whether a more localised approach could deliver greater savings in areas such as adult social care and children's services.

The councils believe that having two unitary councils would best reflect the way people live and work in the area, align better with housing and service demands, and support existing strong links between towns in the north and south, and their relationship with the wider economy.
